#### <u>PUBLIC HEARING</u> <u>TO RECEIVE INPUT REGARDING THE PROPOSED UPDATED</u> <u>TOWN OF CONKLIN COMPREHENSIVE PLAN</u>

Notice of Public Hearing having been duly advertised, Supervisor Finch declared the Public Hearing open at 5:39 P.M. and asked those present to speak either for, or in opposition to, the proposed updated Town of Conklin Comprehensive Plan.

There being no questions or public comments, Supervisor Finch declared the Public Hearing closed at 5:40 P.M.

#### .....

Town Attorney Cheryl Sacco addressed suggestions from the Broome County Department of Planning and Economic Development.

- Recommendation to include the term "pedestrian-friendly" in the Vision Statement in Section II. Ms. Sacco stated that this topic is addressed at length in Section X- C, with discussion of the Multi-Use Trail.
- Recommendation to provide training courses and/or information for residents wishing to age in place. Ms. Sacco stated that this need is being addressed through proposed housing to possibly be funded through the New York State Rising Community Grant.
- Recommendation to check population and housing figures for accuracy and 2010 updating. Ms. Sacco stated that the figures used in the Plan were obtained from the U.S. Census and from Broome County and added that there is no way to check their accuracy.
- Recommendation to provide a business plan to target types of businesses the Town wishes to attract and retain. Ms. Sacco stated that this is already addressed in the Vision Statement, adding that the Town could develop a separate business plan if it chooses to do so.
- Recommendation to provide continued stormwater and flood training for Town representatives. Ms. Sacco stated that this provision is already in place in the Plan.
- Recommendation to mention New Preliminary FEMA 100-Year Floodplain in Section XI. Ms. Sacco stated that this provision is already in place in the Plan.
- Recommendation to include Spill Prevention Plans in Section XI. Ms. Sacco stated that this is already covered by the Town Planning Board under the new updated SEQR (State Environmental Quality Review) process.
- Recommendation to add "and related uses" to Section XIII-C, with reference to gas drilling. Ms. Sacco stated that this section refers to land uses, rather than to extraction per se.

Ms. Sacco stated that this Plan has been shared with the City of Binghamton, the Town of Binghamton, and the Town of Kirkwood. She noted that the Board felt it was not necessary to take action on the recommendations from the Broome County Department of Planning and Economic Development.

Ms. Sacco and the Town Board then addressed the questions found in the Full Environmental Assessment Form (EAF). The Comprehensive Plan is a Type 1 Action for purposes of SEQR (State Environmental Quality Review). The EAF listed which agencies would need to approve adoption of the updated Comprehensive Plan – the Town Board, the Town Comprehensive Plan Committee, and Broome County.

Under Section E.1.h. – Land uses on and surrounding the project – under the heading, "Potential contamination history," it was noted that a portion is listed on the Environmental Site Remediation database. Under Section E.2.h. – Natural resources on or near project – It was noted that the site (the whole Town is addressed in the Comprehensive Plan) contains wetlands, some of which are federally regulated, and that the site is located over or adjoining a principal aquifer and/or a sole source aquifer. It was noted that the site contains species of plant or animal considered rare and/or endangered by New York State and/or the federal government. It was noted in Section E.3 – Designated Public Resources On or Near Project – that the site includes a designated agricultural district, but does not include a registered National Natural Landmark, nor a Critical Environmental Area. It was noted that the site does contain a building listed on the New York State and National Register of Historic Places (the Conklin Town Hall), and is located in or adjacent to an area designated as sensitive for archaeological sites on the New York State Historic Preservation Office archaeological site inventory. The site is not located within a designated river corridor under the Wild, Scenic, and Recreational Rivers Program 6 NYCRR 666.

#### **REPORT: HIGHWAY SUPERINTENDENT**

In addition to his written report, Highway Superintendent Brian Coddington reported that his department burned 50 loads of brush, removed storm damage debris, trimmed trees along the streets, filled shoulders and did ditch work on several roads, and took the tires from the municipal clean-up to Gary's U-Pull-It. He stated that his department had also been repairing potholes and took 20 loads of compost to the CHOW gardens. Mr. Coddington stated that a new starter was installed in the loader, and that he met with the Broome County Sheriff's Department regarding illegal dumping at the Town Highway Garage. He stated that his department set up permits to remove beavers from the Carol Court area and opened the dams three times. Mr. Coddington also stated that he is preparing to resurface several roads in the Town, with funding provided through the "CHIPS" (Consolidated Highway Improvement Program) program.

#### **UPDATE/FEMA BUYOUT PROGRAM**

Assistant to the Supervisor Lisa Houston reported that seventeen offers to buy have been accepted by property owners, who are waiting for closings on the property transfers. She added that she has filed the paperwork for the funding for the costs of closings. Ms. Houston stated that the FEMA (Federal Emergency Management Agency) Buyout project will be completed by the end of 2014, she believes. She stated that she is working on the last 35 properties, adding that the current hold-up is at SEMO (State Emergency Management Office), who must approve the offers to buy. Ms. Houston stated that the Town has until October to request an extension, adding that there is no extra money to spend on demolition, so the Town must wait for the funding to be approved by FEMA/SEMO.

#### **REPORT: WATER & SEWER DEPARTMENT**

In addition to his written report, Public Works Superintendent Tom Delamarter reported that the water meters have been read and billed, and that the Highway Department assisted with two digs for his department. He stated that the pump at Sewer Station 5 was plugged again by rags, adding that this keeps recurring every 3 to 4 weeks to 2 to 3 months. Mr. Delamarter reported that the 2<sup>nd</sup> Quarter testing was done on the Town Landfill. He stated that Little League and softball programs are finished and Teener League is now being played. Mr. Delamarter stated that the pool has been inspected and is now open.

Mr. Dumian asked if there will be individual building lots available also and Mr. Finch replied that he is waiting to hear about this possibility. Mr. Finch stated that the Rising Community grant would pay for a road to be built into the housing development and for the installation of municipal water and sewer service. Mr. Dumian asked if a local builder would be employed for the project and Mr. Finch replied that local builder Christopher Ostrowsky is meeting with the Rising Community Committee about this project, adding that both New York State and the BCIDA would like to employ a local builder. Mr. Bullock stated that the project would be competitively bid.
