The Town Board of the Town of Conklin held a Regular Town Board Meeting at 6:30 P.M. on August 14, 2018, at the Conklin Town Hall. Mr. Dumian, Supervisor, presided. The meeting opened with the Pledge of Allegiance.

#### MINUTES: JULY 10, 2018 REGULAR TOWN BOARD MEETING

Mr. Francisco moved to approve the July 10, 2018 Regular Town Board Meeting minutes as presented.

Seconded by Mr. Platt.

VOTE: Boyle – Yes, Farley – Yes, Platt – Yes, Francisco – Yes, Dumian – Yes. Motion passed unanimously.

#### **CORRESPONDENCE:**

Mr. Dumian acknowledged receipt of a letter from Jonathan Burgman thanking the Town for its "quick response" in posting "No Dumping" signs in an effort to curtail dumping on Powers Road near the power lines.

Mr. Dumian acknowledged receipt of a letter from the New York State Department of Transportation (NYS DOT) stating that the speed limit on Route 7A has been reduced to 45 miles per hour in the area requested, but added that Route 7A now has three different speed limits in different parts of the route, rather than 45 miles per hour throughout. He stated that NYS DOT also reduced the speed limit on the Broome Corporate Parkway to 40 miles per hour from the entrance to Dick's Sporting Goods to Conklin Forks Road.

#### STATE OF EMERGENCY/FLASH FLOODING

Mr. Dumian stated that he issued a State of Emergency for the Town of Conklin because of the flash flooding. He thanked the Conklin Volunteer Fire Department, the Town Highway Department, Broome County, Town of Conklin departments and personnel, mutual aid providers, and all of the volunteers who helped during the crisis. Mr. Dumian stated that Highway Superintendent Brian Coddington had placed his staff at potential trouble spots to deal with emergency situations, adding that the rain Tuesday night was unexpected.

# REGULAR TOWN BOARD MEETING <u>AUGUST 14, 2018</u>

#### **PUBLIC COMMENTS:**

None.

#### **SUPERVISOR'S REPORT:**

The Supervisor's Report is on file in the office of the Town Clerk.

#### **OLD BUSINESS:**

#### **BUILDING MAINTENANCE**

Mr. Dumian stated that a priority of building maintenance is repairing the roof of the Town Hall and Castle, and either repairing or replacing the roof at the Community Center. He stated that he wants two bid specification packages written – one for repairing the roof and one for replacing the roof of the Community Center. Mr. Dumian stated that he spoke with New York State Senator Fred Akshar about grant money to repair the interior of the Castle.

Mr. Dumian stated that the Town will probably have to bond to pay for the Community Center roof, for which he hopes to use Town personnel to save on labor costs. He stated that materials for a metal roof could cost \$15,000 to \$20,000. Mr. Dumian stated that the peaked roof proposed for the Town Hall could cost \$50,000 to \$60,000.

Mr. Dumian stated that he will meet with Delta Engineering on August 15 to discuss the proposed new Community Center. He stated that there is a new day care provider interested in the project, and that provider would finish the interior of the building. Mr. Dumian added that the new Community Center would be "shelter ready," in the event people are again displaced from their homes due to emergency situations.

Mr. Dumian stated that two bridges are closed at the north and south ends of Route 7A, adding that the Red Cross has opened a shelter at Donnelly Elementary School and the residents of the area affected by the closures are being given one more opportunity to evacuate. The bridge at the intersection of Routes 7 and 7A is closed in New York State and PENNDOT (Pennsylvania DOT) closed the bridge in Hallstead, Pennsylvania, near the VFW (Veterans of Foreign Wars) building.

Mr. Platt suggested that the decking on the Community Center roof should be checked for soft spots before it is covered or refinished. Mr. Dumian stated that the roof of the Town Hall must be repaired, noting that it is a flat roof that was installed in 2002 and it is past its 15-year shelf life.

### **SEWER STATION #3 REPAIRS**

Mr. Dumian stated that Sewer Station #3 was not constructed to specifications, adding that it will cost \$36,875 more to repair or replace the bypass pump. He stated that there may be a restock fee for some parts, which he stated the Board will discuss further at the September 11 meeting. Town Attorney Cheryl Sacco affirmed that this is an emergency situation and Mr. Dumian stated that the Town must move forward with the repairs.

#### **BOAT RAMP**

Mr. Dumian stated that Mr. Boyle and Code Officer Nick Vascello met with DEC (New York State Department of Environmental Conservation) officials from Cortland seeking approval of the permit application for the new boat ramp to be constructed in Stillwater. Mr. Dumian asked if the Army Corps of Engineers is in approval of the plan and Mr. Vascello stated that this project is out of the Army Corps' jurisdiction. Mr. Boyle stated that a new plan and new location has been created for the boat ramp, moving it 150 feet north of its original planned location near the new drainage pipe that will be installed. He stated that it will be on property owned by the Town but not acquired through the FEMA (Federal Emergency Management Agency) Buyout program.

#### **RESO 2018-98: ADOPT NEW PLAN/BOAT RAMP**

Mr. Platt moved for the following resolution:

Be It Resolved: that the Town Board of the Town of Conklin adopts the new proposed plan for the Boat Ramp in the Stillwater area, and will move forward with construction, contingent upon the permit being approved by the necessary parties, including receipt of a letter from the Army Corps of Engineers.

Seconded by Mr. Farley.

VOTE: Boyle – Yes, Farley – Yes, Platt – Yes, Francisco – Yes, Dumian – Yes. Motion passed unanimously.

#### **NEW BUSINESS:**

#### **2019 BUDGET**

Mr. Dumian stated that 2019 Budget requests from department heads are due by August 20.

Highway Superintendent Brian Coddington stated that he wants permission to transfer \$28,000 from Unappropriated Funds to pay for 500,000 tons of blacktop needed to repair Town roads. He stated that he is working with the operators of stone quarries within the Town to pay for damage to Town roads.

Mr. Dumian moved for the following resolution:

#### **PUBLIC COMMENTS:**

### FLASH FLOODING/CORBETTSVILLE & BANTA ROAD

Mr. Rick Penny of Corbettsville Road addressed the issue of the damage caused by flash flooding and runoff from Banta Road onto Corbettsville Road. He stated that 2011 was the first time he experienced flooding in his house, after living there for more than 30 years, and now his is one of six houses that get flood water from runoff every time there is a heavy rainstorm. Mr. Penny stated that on October 30, 2012, FEMA gave the Town of Conklin money for repair of the culverts on Banta Road, but the repairs that FEMA requested made the problem worse, not better. He stated that he spoke to a representative from FEMA who stated that the Town should

have notified FEMA if the new culvert system presented an ongoing problem. Mr. Penny stated that ongoing property damage is occurring and the "Town must do something."

Mr. Dumian replied that the Town is seeking funding to help with this problem, adding that the culverts need to be reconfigured on Banta Road. Mr. Penny stated that the DEC cleans the nearby creek every two to three years. Mr. Dumian stated that the amount of water flowing through the sluice pipes brings debris and plugs the sluice pipes, which he stated should be a different size, adding that Mr. Coddington and Town Engineer John Mastronardi would have information about this issue. Mr. Penny stated that the Town needs to install two sluice pipes. Mr. Dumian replied that he is not sure what the downstream effect of doing so would be. Mr. Penny asked, "Who is liable for private property damage?" He added that "FEMA said someone should be liable." Mr. Dumian stated that the Town will ramp up efforts to deal with rain runoff.

There being no further business to come before the Board, Mr. Boyle moved for adjournment, seconded by Mr. Platt. The meeting adjourned at 7:20 P.M.
